## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That JOHN G. AND ETHEL MANNING

of McMinnville, , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Baker Creek and Berry Creek

a tributary of North Yamhill River irrigation

for the purpose of

under Permit No. 14622 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 17, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second, being 0.11 cubic foot per second from Baker Creek and 0.05 cubic foot per second from Berry Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWA NWA, Section 18, Township 4 South, Range 4 West, W. E.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre. Or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.5 acres in the NW1 NW1 Section 18
T. 4 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Northwest corner of Section Eighteen, Township Four South, Range Four West of the Willamette Meridian, thence running South 00° 25' West along the West line of sad Section Eighteen, 1130 feet to a point in the center of Baker Creek, thence following down center line of Baker Creek as follows: North 50° 24' East 225.6 feet, South 52° 00' East 145 feet, South 9° 00' East 120 feet, South 64° 30' East 118 feet, North 63° 00' East 110 feet, North 18° 30' Nast 160 feet, North 28° 00' West 120 feet, South 15° 00' East 285 feet to a point at the junction of Baker Creek with Cowls Creek, thence Clong Cowls Creek as follows: North 43° 00' West 150 feet, North 55° 00' West 200 Feet, North 11° 00' West 90 feet, North 60° 00' West 100 feet, North 7° 30' West 225 feet to a point on the North line of said Section Eighteen, thence along said North line 340 feet to place of beginning. Yamhill County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
