**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** DAVID D. GIESBRECHT

of Route 1, Dallas, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Ash Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 15526 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 17, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.125 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Henry Marshall D.L.C. No. 69, Section 2, Township 8 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Henry Marshall D.L.C. No. 69  
Section 2  
T. 8 S., R. 5 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 24.02 chains South and 11.18 chains East of the Northwest corner of Section 2 in Township 8 South, Range 5 West of the Willamette Meridian in Polk County, Oregon, thence East 9.42 chains to a rock; thence South 27.38 chains to the north boundary of the county road; thence North 68° 52' West on the north boundary of said road 11.13 chains; thence North 20° 00' East 3.08 chains; thence North 20.23 chains to the place of beginning, containing 24.10 acres. Being a part of the Henry Marshall Donation Land Claim, Notification No. 1965, Claim No. (75) 69 in Polk County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
