CERTIFICATE OF WATER RIGHT

This Is to Certify, That H. G. LYON

of Route 2, Dayton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Palmer Creek a tributary of Yamhill River for the purpose of irrigation under Permit No. 16286 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 28, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.179 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Joel Chrisman D.L.C. No. 50, Section 20, Township 4 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on A. D. & Polly Smith D.L.C. No. 48
0.3 acre in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on A. D. & Polly Smith D.L.C. No. 48
6.5 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Joel Palmer D.L.C. No. 80
5.9 acres in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Joel Chrisman D.L.C. No. 50
0.2 acre in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Carney Goodrich D.L.C. No. 49
0.3 acre in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Carney Goodrich D.L.C. No. 49
0.6 acre in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Joel Chrisman D.L.C. No. 50

T. 4 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Southwest corner of the Joel Palmer D.L.C. Notification #1086 Claim #80 in Tp. 4 S., R. 3 W. of the Will. Mer. Oregon, and running thence N. 00° 33' W. along West line of Claim 11.19 chains. Thence West 3.50 chains to the center of the County road. thence N. 26° 30' E. along center of County road 7.66 chains to the West line of said Palmer Claim. Thence S. 00° 33' E. along Claim line 4.01 chains. Thence N. 89° 54' E. 6.24 chains to the Northwest corner of the Joel Chrisman D.L.C. Thence East along North line of Chrisman Claim 10.36 chains. Thence North 1.00 chains. thence East 4.80 chains. Thence South 12.00 chains thence West 15.20 chains to the West line of the Chrisman Claim. Thence S. 00° 02' W. along West line of Claim 3.42 chains to the Northeast corner of the Francis Holdridge Claim. Thence N. 86° 25' W. 6.15 chains to beginning and containing 27.18 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
