. State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Abiqua Creek a tributary of Pudding River

for the purpose of

under Permit No. of the State Engineer, and that said right to the use of said waters 16316 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 19, 1945

that the amount of water to which such right is cntitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.038 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1 NW 1, as projected on Randolph C. Gibson D.L.C. No. 54, Section 24, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.3 acre in the NW1 SW1, as projected on Randolph C. Gibson D.L.C. No. 54 Section 1h
- 1.1 acres in the SE1 NE1, as projected on Randolph C. Gibson D.L.C. No. 54 1.6 acres in the NE SET, as projected on Randolph C. Gibson D.L.C. No. 54 Section 15

T. 6 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point in the center of County Road 18.10 chains N. 89 degrees and 21 minutes E. and 38.223 chains S. from the N.W. corner of the R. C. Gibson D.L.C. in T. 6 S., R. 1 W. of the Willamette Meridian in Marion County Ore. thence W. 9.31 chains to an iron bar. Thence S. 6 minutes E. 5.405 chains to an iron bolt thence W. 9.32 chains to an iron bar in the center of said Road thence N. 5.405 chains to the point of beginning containing 5.03 acres of land in the R. C. Gibson D.L.C. in T. 6 S., R. 1 W., Marion County Ore.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
