This Is to Certify, That HARRY L. BREWSTER AND LETHA BREWSTER

B. B. Route, Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork Willamette River

atributary of Willamette River for the purpose of irrigation

under Permit No. 16454 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 30, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, as projected on Thomas Gibson D.L.C. No. 03, Section 33, Township 20 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to one—eightleth of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to per diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.2 acres in the SW_4^1 SW_4^1 , as projected on Wm. B. Small D.L.C. No. 62 Section 33

T. 20 S., R. 3 W., W. M.
Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 209 feet South of the Westerly Northwest corner of the W. B. Small D.L.C. No. 62, Notif. 761 and running thence East 653 feet; thence South 469 feet, thence West 653 feet, thence North 469 feet to the place of beginning, containing seven acres of land, more or less, all in Section 33, Township 20 South of Range 3 West of the Willamette Meridian in Lane County, State of Oregon; excepting therefrom a tract of land deeded to A. B. Wood on the 21st day of March, 1913 recorded on April 22, 1913 in Vol. 102, page 46 of Deed Records for Lane County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
