CERTIFICATE OF WATER RIGHT

This Is to Certify, That **ROY SAGERT**

of 1220 Fairview Avenue, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Pringle Creek, a tributary of Willamette River for the purpose of irrigation under Permit No. 17798 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 16, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0025 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on James Davidson D.L.C. No. 48, Section 35, Township 7 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acre in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on James Davidson D.L.C. No. 48
 Section 35
 T. 7 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 55 feet South 89° 49' East and 1594.8 feet South 0° 7' East and 75 feet South 89° 49' East from the most Westerly Northwest corner of the James Davidson and wife Donation Land Claim #48 in Township 7 South, Range 3 West of the Willamette Meridian in Marion County, Oregon; said point of beginning being 75 feet South 89° 49' East from the Southwest corner of that certain 60 foot right of way, as shown by deed recorded March 9, 1940 in Vol. 245, page 609, Deed Records for Marion County, Oregon; thence South 89° 49' East along the South line of said right of way 75 feet to a point; thence Southerly parallel with the East line of 12th Street, 150 feet to a point; thence North 89° 49' West 75 feet to a point; thence Northerly and parallel with the East line of 12th Street, 150 feet to the place of beginning. Save and except roads and roadways.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
