CERTIFICATE OF WATER RIGHT

This Is to Certify, That MARGARET HECK

of 1567 N. Pacific Hwy., Cottage Grove State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork Willamette River a tributary of Willamette River for the purpose of irrigation under Permit No. 16195 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 28, 1915

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.121 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on John Cochran D.L.C. No. 55, Section 28, Township 20 South, Range 3 West, W. M., more particularly described as being located in the 8.5 acre tract set forth below.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.2 acres in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on John Cochran D.L.C. No. 55
0.5 acres in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on John Cochran D.L.C. No. 55

T. 20 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point in Section 28, Twp. 20 S. R. 3 West of the Willamette Meridian, North 61 $\frac{1}{2}$ ° West 5.605 chains from the northeast corner of a tract of land deeded by M. M. Rice and C. C. Ashley, thence North 28 $\frac{1}{2}$ ° East 5.18 chains; thence North 61 $\frac{1}{2}$ ° West about 11.50 chains to the center of the channel of the Coast Fork River, thence up said channel in a southwesterly direction to the northwest corner of said tract of land deeded by Martha M. Rice to C. C. Ashley, thence South 61 $\frac{1}{2}$ ° East along the north line of said tract 16.30 chains to the place of beginning in Lane County, Oregon.

Also, Beginning at a point on the south boundary of Lot 5, in the sub-division of the Robert Cochran Estate, as platted and recorded; said subdivision line and said beginning point being located by running N. 61° 13' W. on the south boundary of said Lot 5, 4.80 chains from the intersection of the West boundary of the County Road with the said South boundary of said Lot 5 and running thence S 28° 47' W. 3.59 chains to intersection with the North boundary of the Pacific Highway; thence N. 54° 58' E. following the North boundary of said Highway 8.36 chains; thence N. 61° 13' W. 10.75 chains to a point in or near the center of the channel of the Coast Fork River; thence S. 67° W. following the center of the channel of said River 4.88 chains to the South boundary of said Lot 5; thence S 61° 13' E following the South boundary of said Lot 5, 10.15 chains, more or less, to place of beginning, containing 4.74 acres of land more or less, all in Section 28, Tp 20 S., R. 3 W. WM Lane County, Oregon.
