## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That DONALD SNYDER

of P. O. Box 787, Wolf Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Stenger Creek

atributary of South Umpqua River

for the purpose of

irrigation and domestic use for one family under Permit No. 111,79 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 31, 1931.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.46 cubic foot per second, being 0.45 cubic foot per second for irrigation and 0.01 cubic foot per second for domestic use,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_4^1$ ,  $SW_4^1$ , Section 5,  $NE_4^1$   $NE_4^1$  and  $SE_4^1$   $NE_4^1$ , Section 8, as projected on Alexander Dumond D.L.C. No. 46, Township 30 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in the NE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Alexander Dumond D.L.C. No. 46 8.4 acres in the SW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Chas. H. Beckworth D.L.C. No. 39 7.0 acres in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Chas. H. Beckworth D.L.C. No. 39 19.6 acres in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Alexander Dumond D.L.C. No. 46 Section 8

T. 30 S., R. 4 W., W. M.
Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the North East corner of the C. W.
Beckwith Donation Land Claim No. 39 in Township 30 South Range 4 West of the Willamette Meridian running West 13.50 chains, thence North along the West line of Alexander Dumont Donation Land Claim No. 46, 45 chains, thence East along the North line of said claim No. 46, 24.22 chains to the Section line between Sections 4 and 5, thence South along said section line 56.25 chains to the South line of said Donation Land Claim No. 46, thence West 9.83 chains, thence North 11.25 chains to place of beginning, containing 124 19/100 acres of land in Douglas County, Oregon.

Also, Beginning at the North East corner of said C. W. Beckwith's Donation Land Claim No. 39 in said Township and range, thence running West 37.25 chains, thence South 11.25 chains, thence East 37.25 chains, thence North 11.25 chains to place of beginning containing 31 21/100 acres. The two tracts above described containing 156 acres of land and all situated in Sections 5 and 8 of Township 30 South Range 4 West of the Willamette Meridian and in Douglas County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
