CERTIFICATE OF WATER RIGHT

This Is to Certify, That LAWRENCE McCracken

of Route 1, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 15475 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 23, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.059 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Mitchel Whitlock D.L.C. No. 39, Section 16, Township 6 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.7 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Mitchel Whitlock D.L.C. No. 39
Section 16
T. 6 S., R. 1 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point in the center of a County Road which is 1.32 chains West and 10.01 chains North of the quarter Section corner between Sections 16 and 21 in T. 6 S., R. 1 East of the Willamette Meridian, Marion County, Oregon; thence North 54.10 chains to the center of Butte Creek; thence South 80 degrees East 5.70 chains; thence South 87 degrees 43' East 5.44 chains; thence South 55.21 chains to the center of the County Road; thence north 80 degrees 15' West along the center of said road 9.25 chains; thence North 65 degrees 47' West 2.00 chains to the place of beginning and containing 60.11 acres more or less, and all situated in aforesaid section 16.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
