CERTIFICATE OF WATER RIGHT

This Is to Certify, That FLOYD S. DeLAPP

of Route 8, Box 738, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of McNary Creek a tributary of Rickreall Creek, a tributary of Willamette River for the purpose of domestic use for one family under Permit No. 16015 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 5, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_{2}^{1} , NW_{2}^{1} , Section 25, Township 7 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to —— of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

NW¹/₄ SE¹/₄, as projected on Joshua Shaw D.L.C. No. 60 Section 26 T. 7 S., R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Lot number Thirteen (13), and the East three (3) acres of Tract No. None (9) of Johnson's Cherry Orchard, in Polk County, Oregon, as said lots are shown and designated on the plat of Johnson's Cherry Orchard, now on file and of record in the office of the County Clerk of Polk County, Oregon, who by virtue of his office is the recorder of conveyances for said County and State, save and except therefrom the following described lands and premises, to-wit:

Beginning at an iron bar at the point where the East line of Tract #13 of Johnson's Cherry Orchard, situated in Section 26, Township 7 South, Range h West, Willamette Meridian, Polk County, Oregon, intersects the North line of the Salem-Dallas Highway, ho feet distant and opposite Engineer's center line Station 257 + 07.1, running thence North 88 degrees 30 minutes West along said Highway's North line, 526.92 feet to an iron pipe; thence North 1° 2' East 180.0 feet to an iron pipe; thence North 31° 23' East 101.11 feet to an iron pipe; thence North 1° 3' East 160.6 feet to an iron pipe; thence North 68° 3h' East 255.7 feet to an iron pipe; thence South 88° h5' East 232.5 feet to an iron pipe in the East line of said tract #13; thence South 0° 15' West along said East line 530.02 feet to the place of beginning and containing 5.67 acres of land, more or less.
