of Route 1, Box 234, Hubbard , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek

a tributary of Pudding River

for the purpose of

irrigation
under Permit No. 17196 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from August 9, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.663 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE \(\frac{1}{4} \) NW\(\frac{1}{4} \), NW\(\frac{1}{4} \) SW\(\frac{1}{4} \), NW\(\frac{1}{4} \) SW\(\frac{1}{4} \) and SW\(\frac{1}{4} \) SW\(\frac{1}{4} \), Section 33, Township \(\frac{1}{4} \) South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.6 acres in Lot 3 (SE¹/₄ NW¹/₄)
13.0 acres in SW¹/₄ NW¹/₄
30.0 acres in NW¹/₄ SW¹/₄
4.1 acres in SW¹/₄ SW¹/₄
2.3 acres in Lot 4 (NE¹/₄ SW¹/₄)

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: A certain tract of land situated in the State of Oregon, County of Marion, and in Township Four South, Range One West of the Willamette Meridian and more particularly described as follows, to-wit:- Commencing at Ferrier or Mill Creek at the point where the County Road leading from Thomas Hunt lands to Pudding River crosses said creek; thence running Westerly along the center of said road to East line of land owned by H. C. Stoddard; thence South along said line NINTY-SEVEN rods, thence West along the lands to said H. C. Stoddard until it strikes the East line of lands by the heirs and assigns of Alfred Hovenden, (formerly known as the Joseph Churchill Donation Land Claim); thence South along said line to where it crosses Ferrier or Mill Creek; thence down said creek to the place of beginning, containing FIFTY ACRES, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
