CERTIFICATE OF WATER RIGHT

This Is to Certify, That JIMMIE K. RIDDELL

of Route 1, Independence, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Fork Ash Creek a tributary of Hayden Slough, tributary of Willamette River for the purpose of Irrigation under Permit No. 15848, of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 30, 1944;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.75 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 18 & NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 19, as projected on Aaron Burbank D.L.C. No. 48, Township 8 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80th of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 11.1 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Aaron Burbank D.L.C. No. 48
- 1.7 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Aaron Burbank D.L.C. No. 48
- 3.0 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Aaron Burbank D.L.C. No. 48
- 22.8 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Aaron Burbank D.L.C. No. 48
- Section 18
- 21.4 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Aaron Burbank D.L.C. No. 48
- Section 19

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: The East half (E $\frac{1}{2}$) of the D.L.C. of Aaron Burbank and Sabrina Burbank, his wife, notification No. 1587, Claim No. 40 and 48 in Township numbered Eight (8) South of Range numbered Four (4) West of the Willamette Meridian in Polk County, Oregon. SAVE AND EXCEPT, Eighty (80) acres off of the West side of said half of said Claim, and said East half (E $\frac{1}{2}$) of said Claim being the part set apart by the surveyor General to the said Sabrina Burbank, containing Two Hundred Forty (240) acres, more or less. EXCEPTING a right of way thirty-three (33) feet wide on the East line of the premises from the County Road North to the North line of the Mattie Stewart place, for road purposes. ALSO, the following described premises, to-wit: Beginning at the Southwest corner of the D.L.C. of Leonard Williams and wife, Claim No. 42, in Township numbered Eight (8) South of Range numbered Four (4) West of the Willamette Meridian, in Polk County, Oregon; thence running North 12 degrees 15' West 4.95 chains; thence North 26.75 chains; thence East 25 feet, thence Southerly to the Southwest corner of said Donation Land Claim and place of beginning, containing 1.89 acres of land, more or less, and leaving hereby conveyed in all 235 acres, subject to a right of way easement in favor of P. O. Black.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
