CERTIFICATE OF WATER RIGHT

This Is to Certify, That JAMES C. FOSTER

of Rt. 1, Box 56, <u>McMinnville</u>, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River a tributary of Yamhill River for the purpose of

Irrigation under Permit No. <u>16111</u> of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 11, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for scid purposes, and shall not exceed 0.237 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 SW_4^1 , as projected on Nehemiah Martin D.L.C. No. 83, Section 21, Township 4 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80th of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acres in the NE¹ SW¹, as projected on Nehemiah Martin D.L.C. No. 83 2.7 acres in the SE¹ SW¹, as projected on Nehemiah Martin D.L.C. No. 83 15.6 acres in the SW¹ SE¹, as projected on Nehemiah Martin D.L.C. No. 83 0.5 acres in the NW¹ SE¹, as projected on Nehemiah Martin D.L.C. No. 83 Section 21

T. 4 S., R. 4 W., W.E.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Part of the <u>Nehimiah</u> Martin D.L.C. beginning 9.50 chains north and 25.98 chains West of the corner of Section 21-22-27-28; south 15° 15' West 6.45 chains; thence north 78° 35' West 16.75 chains to east of right bank of Yamhill River; thence following down said river, north 7° east 3.93 chains north 8° 26' east $3.37\frac{1}{2}$ chains north 6° 30' East 4.67 chains South 72° 15' East 2.85 chains north 17° 20' East 4.75 chains to center of county road South 44° 37' East 17.70 chains to place of beginning, containing 20 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
