CERTIFICATE OF WATER RIGHT

This Is to Certify, That PAUL M. SCHEFFER

of Rt. 6, Box 566A Portland (1) , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed spring

a tributary of Fanno Creek, tributary of Tualatin River

for the purpose of

Stock, Fish, Recreation
under Permit No. 17928 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from
August 1. 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_4^1 NE_4^1 SE_4^1 , Section 36, Township 1 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ____ of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Stock, Fish, Recreation in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 36 T. 1 S., R. 1 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at an old 1-1/h" pipe at the NW corner of the E 1/2 of the SE 1/h of Section 36 T. 1 S., R. 1 %., W. M.; thence East 159.2' along the East and West quarter line through said Sec. 36 to a 1/2" pipe and designated as Point A; thence continuing East 10' to the true point of the tract herein described; thence continuing East 4h0.8' to an old 1/2" pipe; thence South 0° 20' East 660' to a pipe; thence West 496.9' to a pipe; thence North 0° h0' West 330.h'; thence East 270.5'; thence North 322'; thence West 360.5'; thence North 8' to true point of beginning".

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
