CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** MARIA WERTH

of Willamina, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Gold Creek a tributary of South Yamhill River for the purpose of Irrigation under Permit No. 18188 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 8, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.028 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Levi Burden D.L.C. No. 46, Section 15, Township 6 South, Range 7 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to  $\frac{1}{80}$ th of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.7 acre in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Levi Burden D.L.C. No. 46  
1.5 acre in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Levi Burden D.L.C. No. 46  
Section 15  
T. 6 S., R. 7 W., W.M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: A part of the Donation Land Claim of Levi Burden Not. No. 7826, Claim No. 46 Township 6 South Range 7 West, Willamette Meridian in Polk County, Oregon and more particularly described as beginning at the Northeast corner of said Donation Land Claim and running thence South 37 $\frac{1}{2}$ ° West 17.23 chains to a stake set on East line of said Donation Land Claim; thence North 52 $\frac{1}{2}$ ° West 6.24 chains; thence South 37 $\frac{1}{2}$ ° West 11.23 chains to a stake; thence North 52 $\frac{1}{2}$ ° West 15.66 chains; to the East line of C. J. Hussey's land; thence North 37 $\frac{1}{2}$ ° East along said line to the center of Yamhill River; thence following down the center of said stream to a point where the North line of said Donation Land Claim intersects the center of said river; thence South 48 $\frac{1}{2}$ ° East along said line to the place of beginning and containing 40.50 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
