of Neal Lane, Lyrtle Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Lyrtle Creek a tributary of South Umpqua River for the purpose of Irrigation under Permit No. 11959 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.016 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SE4, as projected on lazarus Wright D.L.C. No. 45, Section 27, Township 29 South, Range 5 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80th of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.7 acres in the IW1 SE1, as projected on Lazarus Wright D.L.C. No. 45

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Description of L. E. Howard Property:
Beginning at a point on the East line of Neal Lane 2059 feet West and South 1° 45'
West 876.68 feet from the Southwest corner of the Alphens Ireland D.L.C. No. 47,
in Township 29 South, Range 5 West of the Willamette Meridian, said point also
being South 1° 45' West 1700.46 feet from the intersection of the South line of
County Road No. 18-A with the East line of Neal Iane; thence East 300.0 feet; thence
North 1° 45' East 488.0 feet; thence East 571.0 feet; thence North 1° 45' East 318.0
ft. to the Southeast corner of the land deeded by Howard to Willis; thence North
89° 13' West 871.0 ft. along the South line of said Willis land to a point on the
East line of Neal Iane; thence South 1° 45' West 810.26 ft. along said East line of
Neal Iane to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
