CERTIFICATE OF WATER RIGHT

This Is to Certify, That M.R. WIDMER

of 23h0 Queen Ave. Albany , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Calapooya River a tributary of Willamette River

for the purpose of

Irrigation under Permit No. 17209 of the Sto 2 Engineer, and that said right to the use of said waters has been perfected in accordance with the "aws of Oregon; that the priority of the right hereby confirmed dates from August 19. 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN_{4}^{1} NN_{4}^{1} , as projected on George Cline D.L.C. No. 84, Section 13, Township 11 South, Range 4 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80th of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.6 acres in the NV_{2}^{1} NV_{4}^{1} , as projected on George Cline D.L.C. No. 84 Section 13

T. 11 S., R. 4 W., W.M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point which is S. 54° 55' W. 567.6 feet and S. 51° 15' W. 1431.01 feet from the Southwest corner of the Thomas Monteith D.L.C. No. 55 in T. 11 S., R. 4 W. of the Will. Mer. in Linn County, Oregon; thence N. 51° 15' E. 81.01 feet; thence S. 38° 45' E. 460.0 feet to an ½" iron pipe; thence S. 51° 15' W. 364.39 feet to the center of the Calapooya River; thence Northerly down the center of said river to a point which is S. 38° 45' E. 201.0 feet and S. 51° 15' W. 189.0 feet from the place of beginning; thence N. 51° 15' E. 189.0 feet to an ½" iron pipe; thence N. 38° 45' W. 201.0 feet to the place of beginning and containing 2.17 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
