**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** Emil and Amelia Britt

of Jacksonville, State of Oregon, has a right to the use of  
the waters of Little Butte Creek  
for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 498; that the priority of the right thereby confirmed dates from April, 1899 for Tract No. 1 and 1908 for Tract No. 2;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.90 cubic foot per second for Tract No. 1 and 0.30 cubic foot per second for Tract No. 2; measured at the head of the ditch or point where the same leaves the natural stream, from April 1st to October 1st of each year.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
