CERTIFICATE OF WATER RIGHT

This Is to Certify, That Zundel, Golden and Harold

of Lake Creek, State of Oregon, has a right to the use of the waters of North Fork of Little Butte Creek for Tracts No. 1 and 3 and South Fork of Little Butte Creek for Tract No. 2 for the purpose of Irrigation

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 498; that the priority of the right thereby confirmed dates from 1871 for the irrigation of 35.5 acres and 1886 for the irrigation of 47.0 acres in Tract No. 1; 1896 for the irrigation of 10 acres in Tract No. 2 and 1908 for the irrigation of 59.3 acres in Tract No. 3;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.90 cubic foot per second for irrigation of 35.5 acres and 1.50 cubic feet per second for irrigation of 47.0 acres in Tract No. 1; 0.30 cubic foot per second for irrigation of 10 acres in Tract No. 2 and 1.0 cubic foot per second for irrigation of 59.3 acres in Tract No. 3. A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Tract No. 1.

22.0 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$
25.5 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$
35.0 acres in SW $\frac{1}{4}$ SE $\frac{1}{4}$

Tract No. 2

10.0 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$

Tract No. 3

25.0 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$
7.8 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$
14.5 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$
12.0 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 20,
T. 36 S., R. 2 E., W. M.

The water used for irrigation shall be measured at the head of the ditch or the point where the same leaves the natural stream, from April 1st to October 1st of each year.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
