CERTIFICATE OF WATER RIGHT

This Is to Certify, That Paul Applegate

of Scottsburg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream

a tributary of Wells Creek, tributary of Umpqua River domestic

for the purpose of

under Permit No. 13972 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 12, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 7, Section 5, Township 22 South, Range 9 West, W. H.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

domestic in SE_4^1 NW $_4^1$, as projected on Edward Spicer D. L. C. No. 39 Section 8 T. 22 S., R. 9 W., W. H.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the intersection of the West boundary of Donation Land Claim No. 39, with the right bank of the Umpqua River; thence in an Easterly direction along said river bank to a point which is South 10° East from Station 112+51.9 of the Umpqua Highway No. 38, as now located, which is further described as the Westerly boundary of the property deeded by T. W. Andrews to George Applegate; thence N 10° E 771 feet to a pipe driven in the foothill, from which a white fir 30° in diameter bears N 15° W 16 ft; thence N 11° E along a projection of the same line to north boundary of said Donation Land Claim No. 39; thence West approximately 900 feet to the Northwest corner of said D L C No. 39; thence South along the Westerly boundary of said D L C to place of beginning, containing 30 acres, more or less, excepting therefrom the right of way of said Umpqua Highway No. 38, all in Township 22 S R 9 West, Willamette Meridan.

Also Lots 7 and 8 in Section 5, Twp. 225. R. 9 West. W.M.

Also beginning at a point 40 feet south from station 142+51.9 on Umpqua Highway, thence north 86° 30' east 78 feet to beginning of curve to the right of radius 1392.5 ft. thence on said curve a distance of 242.1 feet to east bank of Wells Creek, thence south 112 feet to mouth of Wells Creek, thence on a course north 81° south 320 feet to fir stump 4 feet in diameter, thence north 10° west 69 feet to point of beginning. Being part of Edward Spicer Donation Land Claim No. 39 lying in Section 8, Township 22 South, Range 9,

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
