CERTIFICATE OF WATER RIGHT

This Is to Certify, That Mrs. Antoinette Vanderbeck

of Mt. Angel , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek

a tributary of Pudding River irrigation

for the purpose of

under Permit No. 13184 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 2, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.59 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEA NEA and NEA SEA, as projected on Jeremiah Jack D. L. C. No. 11, Section 8, Township 6 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion at the stream of not to exceed one acre foot per acre for each acre irrigated during any 30-day period and shall be limited still further to a diversion at the stream of not to exceed $2\frac{1}{3}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres in SE¹/₄ NE¹/₃, as projected on Jeremiah Jack D. L. C. 41 12.0 acres in NE¹/₄ SE¹/₄, as projected on Jeremiah Jack D. L. C. 41 Section 8

6.5 acres in NW4 SW4, as projected on Jeremiah Jack D. L. C. 41
Section 9
T. 6 S., R. 1 E., W. M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Commencing on the east boundary of the D. L. C. of Jeremiah Jack and wife, in T. 6 S. R. 1 E. of the W. M., at a point which is 32 chains from the northeast corner of said claim; thence west 45.33 chains to the middle of Butte Creek and in this line on the bank of the Creek is a witness corner from which a fir 40 inches in diameter bears south 31° west 8 links distant and a yew 8 inches in diameter bears south 53° east 33 links; thence from the end of the line in the creek up stream in the middle of the channel to the north boundary of the land, heretofore deeded by W. A. Jack and Mary J. Jack, his wife to Barton Jack; thence east 16.89 chains to Barton Jack's corner; thence north 54° 30' east 3.35 chains to Barton Jack's corner; thence north 43° 43' east 14.60 chains to another of Barton Jack's corners on the east boundary of the aforesaid D. L. C.; thence north 6.21 chains to the place of beginning, FXCEPTING 2.25 acres conveyed to Joseph L. Jones in Book 110 at pages 211 and 215 of Deed Records. ALSO beginning at a point in the center of the Molalla and Silverton County Road which point is 63 feet east of an angle stake, which is south 54° 30' west 3.35 chains from another angle stake, which is south 43° 43' west 14.60 chains from the northeast corner of a tract of land deeded by W. A. Jack and Mary J. Jack, his wife, to Barton Jack, as shown by deed recorded in Book 60 page 120, Deed Records, and which beginning point is in Section 9, T. 6 S. R. 1 E. of the W. M., and being a part of the Jeremiah Jack D. L. C.; thence west 12 rods; thence south 7 rods to the center of said Molalla and Silverton Road; thence northeasterly along the center of said road to the place

of beginning.

ALSO beginning at a point in the center of the Molalla and Silverton road which point is 63 feet east of an angle stake, which is south 54° 30' west 3.35 chains from another angle stake which is south 43° 43' west 14.60 chains from the northeast corner of a tract of land deeded by William A. Jack and Mary J. Jack, his wife, to Barton Jack as shown by deed recorded in Book 60 page 120, Deed Records, and which beginning point is in Section 9, T. 6 S. R. 1 E. of the W. M., thence west 53½ rods to a stake; thence south 36 rods to the center of the said Molalla and Silverton Road; thence northeasterly along the center of said road 64½ rods to the place of beginning, EXCEPTING from this conveyance a certain tract of land heretofore conveyed to J. E. Jack on February 15, 1911, in Book 118 page 336, Deed Records.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
