CERTIFICATE OF WATER RIGHT

This Is to Certify, That Elmer E. and Ida D. Benham

of Coquille, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two unnamed streams, being 0.02 c.f.s. from West Branch and 0.01 c.f.s. from East Branch a tributary of Rink Creek for the purpose of domestic use for 4 families under Permit No. 16070 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 11, 1914

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ from East Branch and SE $\frac{1}{4}$ NW $\frac{1}{4}$ from West Branch, Section 7, Township 28 South, Range 12 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Property on which water is to be used is a part of that more explicitly described as follows: (William J. Bonnell) The Southwest quarter of Northeast quarter and the West half of the Southeast quarter of Section 7 in Township 28 South, of Range 12 West of the Willamette Meridian, containing 120 acres of land, more or less. Also a strip of land of uniform width off of and extending along the East side of the Southeast quarter of the Northwest quarter and the East half of the Southwest quarter of the said Section 7, and containing in said strip of land 15 acres; and containing in both parcels 135 acres of land, more or less; in Coos County, Oregon.

(James A. Porter's property) Beginning at a Three-Quarter Inch (3/4") iron pipe driven one foot below the surface of the ground, in the southerly right of way line of Rink Creek County Road, which is 2.7 feet South and 1739.3 feet East of the quarter-section corner on the West line of Section Seven (7) T. 28 S., R. 12 W. WM: running thence South 19 degrees 05minutes West 100 feet to a one-inch (1") iron pipe; thence South 81 degrees 19 minutes East 80.5 feet; thence North 7 degrees 13 minutes East 100 feet to said right of way line; thence North 82 degrees 47 minutes West 60 feet along said right of way line to the place of beginning; In Coos County, Oregon, and containing in all 0.16 acres of land more or less.

Elmer J. Cunningham's property— Beginning at a 3/4 inch iron pipe driven one foot below the surface of the ground in the southerly right-of-way line of Rink Creek, Coos County Road, as the same is now located, which point is approximately 2.7 feet south and 1739.3 feet east of the quarter section corner on the west line of Section

Seven (7), Township 28 South, Range 12 West of the Willamette meridian, in Coos County, Oregon, running South 19° 05' West 100 feet to one inch iron pipe; thence running North 70° 55' West 100 feet; thence North 19° 05' East 100 feet to said right-of-way line of said Rink Creek Coos County Road, thence South 70° 55' East 100 feet along said right-of-way line to the place of beginning, all in Coos County, Oregon (Piece of land containing 0.12 acres, more or less)

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
