CERTIFICATE OF WATER RIGHT

This Is to Certify, That Rolland R. Woodford

of Merlin, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Jump Off Joe Creek, a tributary of Rogue River, for the purpose of irrigation under Permit No. 16666 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 8, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.15 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ and SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 13, Township 35 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.0 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$
3.0 acres in SW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 13
T. 35 S., R. 7 W., W. M.

Property on which water is to be used is a part of that more explicitly described by the appropriator as follows:

Beginning at the West one quarter of Section 13 in Township 35 South Range 7, West of the Willamette Meridian in Josephine County Oregon; thence running South along the Section line between Sections 13 and 14 a distance of 2540 feet to the Southwest corner of said Section 13; thence East 350 feet; thence North 1087 feet; thence North $46^{\circ} 40'$ East 990 feet; thence East 423 feet; thence North $11^{\circ} 25'$ West 891.8 feet to the Northeast corner of the Northwest one quarter of the Southwest one quarter of said Section 13; thence running West 1320 feet to the place of beginning, containing 48.1 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
