## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That Marion Dunlap

of Route 1, Jacksonville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Big Applegate River, Dunlap Spring and Unnamed Gulch a tributary of Applegate River, tributary of Rogue River for the purpose of irrigation, domestic and stock under Permit No. 16699 of the State Engineer, and that said right to the use of said waters

under Permit No. 16699 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 21, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.083 cubic foot per second, being 0.063 c.f.s. from Eig Applegate for irrigation, 0.01 c.f.s. from Spring for domestic and 0.01 c.f.s. from Gulch for stock

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SE_4^1$  SW2 and SW2 SW4, Section 28 and SW4 NE4, Section 32, Township 38 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres and domestic in SW1 SW1 Section 28
stock in SW1 NE1 Section 32
T. 38 S., R. 3 W., W. H.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows:

Warranty Deed registered in records of Jackson County Clerks office show that applicant owns  $SW_4^+$   $SW_4^+$  section 28, the  $NE_4^+$  section 32 and the  $NW_2^+$   $NW_4^+$  section 33 all in T. 38 S. R. 3 W. W.M.

Also the following described premises situated in Jackson County, Oregon, to-wit:

The Northwest quarter of the Northwest quarter of Section 33, and the East half of the Northeast quarter of Section 32, in Township 38 South, Range 3 West of the Willamette Meridian.
