## CERTIFICATE OF WATER RIGHT

This Is to Certify, That Rudolph R. Bischoff and Elizabeth Bischoff

of Route 1 Box 43, Murphy , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Grays Creek a tributary of Applegate River for the purpose of

supplemental irrigation

under Permit No. 16965 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 29, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 SW4, as projected on B. O. R. Lurphy D. L. C. No. 40, Section 20, Township 37 South, Range 5 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed be acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. \*

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

\* Water shall be used under the primary right when available and under the right evidenced by this permit when not available under the primary right.

7.5 acres in Lot 1 (SW\(\frac{1}{4}\) \W\(\frac{1}{4}\)
15.5 acres in Lot 2 (SE\(\frac{1}{4}\) \W\(\frac{1}{4}\)
3.0 acres in SE\(\frac{1}{4}\) \W\(\frac{1}{4}\), as projected on B. O. R. Murphy D. L. C. 40

T. 37 S., R. 5 W., W. M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows:

All of Lots 1, 2 and 3 and that portion of the B.O.R. Murphy Donation Land Claim No. 40 lying East of Grays Creek and South of Applegate River, all being in Section 20, Township 37 South Range 5 West of the Willamette Meridian in Josephine County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
