CERTIFICATE OF WATER RIGHT

This Is to Certify, That Edward A. Gent

of 1170 Coburg Road, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unmamed stream and two springs

a tributary of Long Tom River

for the purpose of

irrigation
under Permit No. 17147 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from July 12, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second, being 0.15 c.f.s. from stream and 0.01 c.f.s. from springs

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NE4 NE4, as projected on Thompson D. Hinton D. L. C. 37, Section 5, Township 17 South, Range 5 West, W. M. and SE4 SE4, as projected on Thompson D. Hinton D. L. C. 37, Section 31, Township 16 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered ly the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.4 acres in SE_4^1 SE_4^1 , as projected on Thompson D. Hinton D. L. C. 37 Section 31

0.3 acre in SH_4^1 SH_4^1 , as projected on Thompson D. Hinton D. L. C. 37 Section 32

T. 16 S., R. 5 W., W. M.

0.4 acre in NW4 NW4, as projected on Thompson D. Hinton D. L. C. 37 Section 5

3.2 acres in NE¹/₄ NE¹/₄, as projected on Thompson D. Hinton D. L. C. 37 Section 6

T. 17 S., R. 5 W., W. H.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Commencing at a point on the Northwesterly line of the Thompson D.
