CERTIFICATE OF WATER RIGHT

This Is to Certify, That Walter I. Edmonds

of 1801 N. Stephens St., Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Umpqua River, a tributary of Umpqua River for the purpose of domestic use for one family and irrigation under Permit No. 17273 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 12, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second, being 0.01 c.f.s. for domestic and 0.01 c.f.s. for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Joseph McKinney D. L. C. 45, Section 23, Township 26 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.20 acre in NE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Joseph McKinney D. L. C. 45
0.60 acre in NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Joseph McKinney D. L. C. 45
domestic and 0.10 acre in SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Joseph McKinney D. L. C. 45
Section 23
T. 26 S., R. 6 W., W. M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the North corner of property described in County Clerk's Deed Records in Vol. 95, page 452, Instrument No. 91261, said beginning point being 1357.3 feet North and 1214.1 feet west of the quarter section corner between sections 23 and 24 Township 26 South, Range 6 West, Willamette Meridian, on the Southerly right of way line of County Road; thence running S. 49° 43' W. 295.1 feet along the Westerly side of said recorded property to a point on the Northerly bank of the North Umpqua River; thence N. 13° 43' W. 214.0 feet along said river bank to a point; thence N. 54° 19' E. 213.0 feet to a point on the Southerly line of said road; thence S. 33° E. 175.0 ft. along said road line to the place of beginning, containing 1.1 acre, more or less, and situated in the Northeast Quarter of Section 23, Township 26 South, Range 6 West, Willamette Meridian, Douglas County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
