CERTIFICATE OF WATER RIGHT

This Is to Certify, That H. W. Wright

of Rt. 1 Box 335, Eagle Point, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River a tributary of for the purpose of irrigation

under Permit No. 17295 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 30, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0125 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 17, Township 35 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighthieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{3}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, and shall be further limited to a diversion of not to exceed 0.0125 c.f.s.,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acre in Lot 1 (NW $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 17
T. 35 S., R. 1 W., W.M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point which lies North 1300 feet, North 64°-20' West 1035.8 feet, and South 24°-30' West 168.3 feet from the Section Corner common to Sections 16, 17, 20, and 21, in Township 35 South, Range 1 West, of the Willamette Meridian, in Jackson County, Oregon, the true point of beginning; and from said point, run thence South 0°-20' East 123.0 feet; thence South 26°-09' West 18.0 feet; thence North 65°-23' West 655.0 feet; thence North 22°-07' East 80.0 feet; thence North 25°-34' East 60.0 feet; thence South 55°-45' East 506.0 feet to the true point of beginning.

Beginning at a point which lies North 1300 feet, North 64°-20' West 1035.8 feet, South 24°-30' West 34 feet, from the section corner common to sections 16, 17, 20 and 21, in Township 35 South, of Range 1 West of the Willamette Meridian, in Jackson County, Oregon, the true point of beginning; and from said point, run thence South 24°-30' West 134.3 feet; thence North 55°-45' West 606.0 feet; thence North 25°-34' East 140.0 feet; thence South 64°-20' East 605.6 feet to the true point of beginning;

Also, beginning at a point which lies North 1300 feet, North 64°-20' West 1035.8 feet, South 24°-30' West 168.3 feet South 0°-20' East 123.0 feet, and South 26°-09' West 18.0 feet from the section corner common to Sections 16, 17, 20 and 21, in Township 35 South, of Range 1 West of the Willamette Meridian, in Jackson County, Oregon, the true point of beginning; and from said point, run thence South 26°-09' West 120.0 feet; thence North 67°-48' West 645.0 feet; thence North 22°-07' East 145.0 feet; thence South 65°-23' East 655.0 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
