**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** J. Clifford Hess

of Route 2 Box 266, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Umpqua River, a tributary of Pacific Ocean, for the purpose of irrigation under Permit No. 17509 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 24, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.47 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 24, Township 26 South, Range 7 West, W. M. and SE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 30, Township 26 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.5 acres in SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Evan T. Grubb D. L. C. 59

- 16.0 acres in SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Evan T. Grubb D. L. C. 37  
being within Lots 7 and 8, Block 7, Plat "A"

Section 24  
T. 26 S., R. 7 W., W. M.
- 10.0 acres in SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Solomon J. Grubb D. L. C. 40  
Section 29
- 10.0 acres in SE $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected on Solomon J. Grubb D. L. C. 40  
Section 30  
being within Lots 3, 4 and 5, Block 2, Plat "B"  
Roseburg Home Orchard Tracts  
T. 26 S., R. 6 W., W. M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows:

Lots 3, 4 & 5 Block 2 Plat B Roseburg Home Orchard Tracts  
Lot 8 Block 7 Plat A. Roseburg Home Orchard Tracts

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
