## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That C. A. Patchett

of III S. Jackson Street, Roseburg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpque River

a tributary of Umpqua River irrigation

for the purpose of

under Permit No.16519 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 11, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0075 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NET NHT). Section 22, Township 27 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre in Lot 4 (SE<sup>1</sup> NW<sup>1</sup>) Section 22 T. 27 S., R. 6 W., W. M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a ½" x 18" iron pipe, from which the section corner common to sections 15-16-21 and 22 in Twp. 27 S. of R. 6 West of the W.M. in Douglas County, Oregon bears N. 17° 49' W 1992.3 feet; thence N 1° 10' E 208.0 feet to the center of the South Umpqua River, thence S. 52° 10' E 121.3 feet up the center of the South Umpqua River, thence S. 72° 12' E. 231.4 feet up the center of the South Umpqua River, thence S. 69° 13' E. 281.6 feet up the center of the South Umpqua River, thence S. 69° 143' E. 281.6 feet up the center of the South Umpqua River, thence S. 69° 140' E. 281.6 feet up the center of the South Umpqua River, thence S. 60° 16' W. 60.0 feet to a ½" x 20" iron pipe; thence S. 3° 29' W. 60.0 feet to a ½" x 20" iron pipe; thence S. 3° 29' W. 60.0 feet to a ½" x 20" iron pipe, from which 12" white oak, marked C S B T bears S 70° 15' W 18.5 feet, thence S. 56° 36' W 18.6 feet to a 3/4" x 18" iron pipe, thence S 66° 09' W 77.2 feet to a 1½" x 3/4" x 12" strap iron, thence S 77° 17' W 73.7 feet to a 1" x 20" strap iron, thence S 85° 25' W 87.1 feet to a ½" x 24" iron pipe, thence N 80° 09' W. 155.8 feet to a ½" x 12" iron bolt, thence N 73° 57' W 103.4 feet to a 1½" x 18" iron pipe from which 8" White Oak marked C S B T bears N 4" 30' E 17.0 feet, thence N 1° 10' E 255.5 feet to the place of beginning, and containing 3.92 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
