CERTIFICATE OF WATER RIGHT

This Is to Certify, That James A. Henry

, has made proof of Route 4 Box 795, Roseburg , State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed springs and Forter Creek

a tributary of Termile Creek

for the purpose of

irrigation and domestic use for one family of the State Engineer, and that said right to the use of said waters under Permit No. 17799 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 17, 1947

that the amount of water to which such right is entitled and kereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.082 cubic foot per second, being 0.001 c.f.s. from springs for domestic and 0.081 c.f.s. from Porter Creek for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWA NWA, as projected on Peter Saars D. L. C. 55, Section 28, Township 28 South, Range 7 West, W. M. from springs and NEA NEA, as projected on Peter Saars D. L. C. 55, Section 29, Township 28 South, Range 7 West, W. H. from Porter Creek

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 0.2 acre in NW4 NW4, as projected on Peter Saars D. L. C. 55 Section 28

> 4.2 acres in NE¹/₄ NE¹/₄, as projected on Peter Saars D. L. C. 55 0.6 acre in Lot 2 (SE¹/₄ NE¹/₄)

1.5 acres in SEA NEL, as projected on Peter Says D. L. C. 55

Section 29 T. 28 S., R. 7 W., W. H.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Lot One (1) of Section 29, Township 28 South, of Range 7 West of the W.M., containing 23.07 acres more or less. Also that portion of the Peter Saar Donation Land Claim No. 55, lying within Sections 28 and 29 in Township 28 South Range 7, West of the Willamette Heridian described as follows: Beginning at the Southwest corner of said Claim No. 55; the ce North on the West line thereof 55 rods; thence East 130 rods and 15 feet, thence South 55 rods to the South line of said claim, thence West on said South line 130 rods and 15 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
