**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** William J. Webber

of Route 1, Sutherlin, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed creek a tributary of Camas Swale Creek for the purpose of domestic use for one family under Permit No. 17800 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 19, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 10, Township 25 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Thomas Sutherlin D. L. C. 40

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Lot 15, Block 1, Flat A of the Sutherlin Land and Water Company, containing 19,511 acres, as surveyed, platted, and recorded in the office of the County Clerk of Douglas County, Oregon.

Beginning at corner #1, a pipe, from which the quarter corner Sections 10 and 15 Township 25 S, R 5 W, WM., Douglas County, State of Oregon, bears S 89° 54' W 255.8 ft.;

Thence N 89° 54' E 330.3 ft.; to corner #2 a cross on bed rock; thence S 00° 27' W 388.4 ft. to corner #3, on N bdy. of Cnty. Road; Thence S 75° 43' W 342 ft. to corner #4, on north boundary of County Road;

Thence N 00° 27' E 472.2 ft. to corner #1, the place of beginning, containing 3.27 acres, more or less.

Also, beginning at the center of Sec. 10, T 25 S, R 5 W, WM., Douglas County, Oregon.

Thence S 00° 19' W 2674.0 ft.;

Thence N 89° 45' E 586.1 ft.

Thence N 00° 18' E 973.6 ft.; thence S 89° 48' E 331.8 ft.; thence S 00° 20' W 348.1 ft.; thence N 67° 50' E 150.0 ft.; thence N 00° 20' E 1926.8 ft.; thence N 89° 48' W 1056.5 ft., to place of beginning, all located in Sec. 10, T 25 S, R 5 W., WM., containing 55.25 acres, more or less.

Also, beginning at the  $\frac{1}{4}$  cor. between Secs. 10 and 15 in T 25 S, R 5 W, Wm., Douglas County, Oregon; thence S a distance of 536.4 ft; thence  $\angle 77^{\circ} 23'$  E a distance of 260.0 ft.; thence N a distance of 472.2 ft.; thence S  $89^{\circ} 51'$  W a distance of 255.8 ft., to place of beginning, containing 2.96 acres, more or less.

East half ( $E\frac{1}{2}$ ) of Lot Fourteen (14) Block One (1) of the Sutherlin Land and Water Company's Flat "A" as surveyed, platted and recorded in the office of the County Clerk of Douglas County, Oregon, and containing 9.423 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
