CERTIFICATE OF WATER RIGHT

This Is to Certify, That Frank C. Dean

of Route 1 Box 117, Central Point , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two springs and the Dean Reservoir constructed under Permit No. R-890 a tributary of Willow Creek Watershed, tributary of Bear Creek for the purpose of irrigation and domestic use for one family under Permit No. 17810 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the provity of the right hereby confirmed dates from April 25, 1917

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.135 cubic foot per second, being 0.01 c.f.s. for domestic and 0.05 c.f.s. for irrigation from south spring and 0.075 c.f.s. for irrigation from north spring and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SI_4^1 SI_4^1 and SE_4^1 NI_4^1 , Section 5, Township 37 South, Range 2 West, N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, from direct flow and storage from reservoir to be constructed under Permit No. R-890,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

domestic and 8.0 acres in SEA NWA 2.0 acres in SWA NWA Section 5 T. 37 S., R. 2 W., W. M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows:

Tract No. 1: Begin at the S. W. Cor. of N.C. Dean D.L.C. #N8, in Twp. 37 S., Range 2 W. of the W. N., thence east on the south boundary line of said claim 37.90 chs. to corner; thence north 35 chs. and 20 links to the south line of E. L. Farra land; thence west 37.90 chms. to the west boundary of said claim; thence south 35 chms. and 30 links to place of beginning; excepting and reservoir 55 acres heretofore deeded to R.H. Dean by Anna Dean, Oct. 3rd, 1884, recorded Vol. 11, page 576 Deed Records of Jackson County, Oregon, and also excepting the 54 acre tract deeded to Jannie N. Jarvie, recorded Vol. 99, page 630 said Deed Records:

Tract No. 2: Government Lots 3 and 5, in Section 5, Twp. 37 S., Range 2 W. of W. M.;

Tract No. 3: Commence at the S.W. corner of Government Lot 4, in Sec. 5, Twp. 37 S., R. 2 W., of W.M., thence east 3 chns. for place of beginning; thence east 17 chns. to the S. W. Corner of Government Lot 3, said Sec.; thence North on west boundary of said Lot 3 to the south line of D.L.C. #48, said twp. and Range; thence west on the south boundary of said D.L.C. 2.50 chns. to the S.W. Corner of said claim; thence north on the west boundary line of said Claim 12 chns. to the S. E. corner of Lot 5, in said Sec. 5; thence west on the south line of said Lot 5, 10.44 chns.; thence south 12° west 20.15 chns. to the place of beginning.

Tract No. 4: Beginning at a point on the County Road where the east boundary line of Huston DC.#49 in Twp. 37 S., Range 2 W. of W.M. crosses said road, and extending thence north 40° West 22 rods to stake on north side of said road, as southwesterly corner; thence North 21°-11' east 11.40 chas. to east boundary line of Huston D. L. C. as the north corner; thence South along the east boundary line 14 chas. to a stone at the S.E. corner, the place of beginning, containing 4 acres, more or less;

Tract No. 5: Commence at the S.E. corner of D.L.C. No. 49, in Twp. 37 S., Range 2 W. of W.M.; thence west 9.50 chms.; thence north 12° east 13.18 chms. to the county road; thence south 28° east along the south side of said County road 7.60 chms. to where said road intersects the west line of D.L.C. No. 48; thence South along the west line of said D.L.C. 48, 8.50 chms. to the beginning;

Tract No. 6: The S.W. 7 of the S.W. 7 of Section 5, in Tmp. 37 S., Range 2 West of W.W.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
