**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** C. W. Raymond

of Disston Route, Cottage Grove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Row River a tributary of Coast Fork Willamette River for the purpose of irrigation under Permit No. 17920 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 12, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 36, Township 20 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres in SE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on William Ogleby D. L. C. 66  
4.2 acres in NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on David Moseby D. L. C. 65  
0.8 acre in NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on William Ogleby D. L. C. 66  
Section 36  
T. 20 S., R. 3 W., W. M.

Property on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point West 2548.1 feet and South 100.4 feet from the most northerly Northeast corner of the D. Mosby Donation Land Claim #65, Section 36, Township 20 South, Range 3 West, Willamette Meridian; thence North 15 degrees 24' East 266.6 feet; thence South 79 degrees 10' East 773 feet to a point in the center of a road; thence along center of road South 19 degrees 55' West 27.2 feet; thence South 10 degrees 15' West 239.4 feet along center of a road which is the West boundary of the R. T. Martin's property; thence North 79 degrees 00' West 793.0 feet more or less, to the point of beginning all in Lane County, Oregon.

Beginning at a point west 2477.3 feet and North 156.6 feet from the most northerly Northeast corner of the D. Mosby Donation Land Claim #65, Section 36 Township 20 South, Range 3 West, Willamette Meridian; thence North 15 degrees 24' East 266.6 feet; thence South 79 degrees 0' East 793.5 ft. to a point in the center of a road; thence along center of road South 19 degrees 55' West 266.6 feet; thence North 79 degrees 10' West 773.0 feet more or less to the point of beginning, all in Lane County, Oregon. Beginning at a point West 2406.5 feet and North 413.7 feet from the most northerly Northeast corner of the D. Mosby Donation Land Claim #65, Section 36 Township 20 South, Range 3 West, Willamette Meridian; thence North 15 degrees 24' East 266.6 feet; thence South 78 degrees 50' East 814.5 feet to the center of a road; thence along center of road South 19 degrees 55' West 266.6 feet; thence North 79 degrees 0' West 793.5 feet, more or less, to the point of beginning, all in Lane County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
