domestic user for two families the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 16, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5 gallons per minute

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NW1 SE1, Section 26, Township 37 South, Range 1
Nest, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to _____ of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

NW1 SE1 Section 26 T. 37 S., R. 1 W., W. M.

Property on which water is to be used is a part of that more explicitly described

by appropriator as follows:

Beginning at the center of Section 26, Township 37 South, Range 1 West, of the Willamette Meridian, thence West along center of Section line 175 feet (more or less) to the center of the County Road, thence South 51° - 11' East 600 feet more or less to the North and South center line of said Section 26, thence North along said center line 375 feet (more or less) to the point of beginning, being part of Lots 1 and 2, Monitor Orchard Tracts: Beginning at the center of Section 26, in Township 37 South, Range 1 West of the W.M. being the Northwest corner of the Southeast quarter of said Section, and running North 88° - 31' East on the center section line 851.1 feet; thence North 0° - 07' East 1,117.5 feet to the Northeast corner of the tract of land described in Vol. 206 at Page 607, Deed Records of Jackson County, Oregon; thence North 89°11' West on the North line of said tract 2770.8 feet to the Northeasterly line of the County Road known as Cherry Lane; thence South 51°-11' East along said road line 2117 feet to the North and South center line through said Section 26, thence North on said center line 375 feet to the place of beginning, in said County Road along the East line of above tract, which said land in said County Road 'Es' excepted therefrom. Excepting that part, commencing at the Northwest corner of that certain tract of land in Section 26, Township 37 South, Range 1 West of the Willamette Meridian in Jackson County, Oregon, as said tract is described in that certain Deed appearing of record in Volume 250 at Page 354, Deed Records of Jackson County, Oregon, and from said point running thence Easterly, along the Northerly line of said said tract, 1164 feet; thence Southerly, at right angles to the said Northerly Lane, as now laid out, established and used as a

County Road in said Section, Township and Range; thence Northwesterly, along the said Easterly side line of the said Cherry Lane, 1343 feet, more or less, to the point of beginning. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of

use herein described.
