## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That JAMES P. SCADDING

of Route 1, Box 267, Rogue River Oregon , State of , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Evans Creek

Rogue River a tributary of irrigation

for the purpose of

17272 of the State Engineer, and that said right to the use of said waters under Permit No. has been perfected in accordance with the laws of Oregon; that the priority of the right hereby September 10, 1946 confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0125 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 NW4, Section 4, Township 35 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed his acre for the per acre for each arre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1 acre in NE% NV% Section 4, T. 36 S., R. 4 V., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the Southeast corner of the West Half of the Mortheast Quarter of the Northwest Quarter of Section 4, in Township 36 South, of Range 4, West of the Willamette Meridian, Jackson County, Oregon, and running thence North 253 feet, thence West 716 feet to the East side of the new County Road, for the true point of beginning; Thence East 716 feet to the East line of the West Half of the Northeast Quarter of the Northwest Quarter of said Section 4; thence North 236 feet; thence West 625 feet to the East side of the new County Road; thence along the East side of said Road, South 30°00' West 200 feet; thence along the East side of said Road, South 8° East 63.5 feet to the true point of beginning—containing 3.7 acres more or less. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
