CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAM F. JOHNSON

of Court House, Grants Pass , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

a tributary of for the purpose of irrigation

under Permit No. 18717 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 11, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $N\mathbb{T}_4^1$ S \mathbb{T}_4^1 , Section 21, Township 36 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1/3 acre in NW\ 5W\\\
Section 21
T. 36 S., R. 5 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point which lies South 0°26' East a distance of 440 feet; thence South 72°49' East a distance of 764.4 feet from the West Quarter corner of Section 21, Township 36 South, Range 5 West of the Willamette Meridian, Josephine County, Oregon, and run thence South 72°49' East a distance of 62.8 feet; thence due South to the South line of Government Lot 4 in said section 21 on the North bank of Rogue River; thence Northwesterly along the South line of said Government Lot 4 to a point which lies due South of the point of beginning; thence North to the point of beginning.

LESS AND EXCEPT that parcel of land described as follows:

Beginning at the West Quarter corner of said Section 21, Township 36 South, Range 5 West of the Willamette Meridian, Josephine County, and run South 0°26° East 440 feet; thence South 72°49' East, 3 feet; thence South 8 feet; thence North 72°49' West 3 feet; Thence North 8 feet to the true point of beginning. Also an undivided 1/4th interest in the following described parcel of land: Beginning at the West Quarter Corner of Section 21, Township 36 South, Range 5 West of the Willamette Meridian, Oregon, and run South 0°26' East 140 feet; thence

South 72°49' East a distance of 764.4 feet to the true point of beginning; thence South 72°49' East 3 feet; thence South 8 feet; thence North 8 feet; thence North 8 feet; thence South 72°49' East 3 feet to the true point of beginning. There is located upon the above described premises a well, pump and pump house. Above described property shown as Lot 2 in M. L. Flood Tracts.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
