## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That O. L. WILLIAMS

of R. R. Box 5, Shady Cove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River a tributary of for the purpose of

irrigation under Permit No. 18855 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 25, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.013 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NVL, Section 15, Township 34 South, Range 1 West, V. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.30 acres in Lots 13-14
0.35 acres in Lots 15-16
0.35 acres in Lots 17-18
Of the unrecorded 0. W. Williams Sub-division being within the SET NWT, Section 15
Township 34 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Commencing at a point where the line between Govt. Lots 4 and 5 in Sec. 15 T. 34 S., R. 1 W., W. M. in Jackson Co., Oregon, intersects the west bank of the Rogue River; running thence westerly along said line to a point where the same intersects the easterly boundary of the Carter Lake Hwy. thence in a southwesterly direction along the easterly boundary of said Highway 265 ft. to a point defined in Vol.208, Page 243, Deed Records of Jackson Co., Oregon, for a true point of beginning; thence southwesterly along the easterly boundary of said Crater Lake Highway 350 ft. to an iron pin, said point also being the northwest corner of the land described in Vol. 226, Page 432, of the Jackson Co Deed Records; thence easterly parallel with the north line of said Lot 4 a distance of approximately 460 ft. to the high water mark of the Rogue River; thence northerly along the high water mark of Rogue River a distance of 345.6 ft. more or less to the southeast corner of the land described in Vol. 208, Page 248, Jackson Co. Deed Records; thence west a distance of approximately 390 ft. to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
