## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That DR. GUY L. BOYDEN

of 1735 N. Wheeler, Portland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of five unnamed springs a tributary of

irrigation and domestic use of one family under Permit No. 15075 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 4, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.015 cubic foot per second, being 0.005 c.f.s. for irrigation and 0.01 c.f.s. for domestic,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWA NWA as projected on Fredrick W. Geer D.L.C. No. 41, Section 32, Township 3 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.2 acres in SW1 NW1, as projected on Fredrick W. Geer D.L.C. No. 41 0.1 acres & domestic in NWA SWA, as projected on Fredrick W. Geer D.L.C. No. 11 Section 32, Township 3 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

PARCEL NO.1/ A part of the D.L.C. of Fredrick W. Geer and wife, and designated in the survey of the United States as notification No. 1089 and Claim No. 11 in T. 3. South, R. 1 W. of the W. H., and further described by beginning at a point 15 chs. E. of the quarter section corner between sections 29, 30, 31 and 32 in the aforesaid Township and Range; N. 50% 3. 59 links intersects a red Fir 60 inches in diameter 11 chs. to corner where an iron bar is driven, from which an ash tree 6 in. in diameter bears S. 50% E. 24 links distance, said tree is marked P.S.B.T. thence S. 39% W. 5 chs. and 50 links where a pint bottle is deposited 12 inches deep in the ground; thence S. 502°E. at 10 chs. an iron bar is driven in the ground and stake is set for a witness corner from which a red fir 4 inches in diameter bears S. 12° W. 10 links at 11 chs. set corner on line of the meanders of said River; thence down said river N. 39%° E. 5 chs. and 50 links to the place of beginning, containing 6.05 acres, more or less.

PARCEL NO.2/ Beginning at a point N.  $39\frac{1}{2}^{\circ}$  E. 4 chs. and 80 links from the quarter Section corner between sections 29, 30, 31 and 32 in T. 3. S. R. 1. %, of the W. M. at which point a bottle is deposited 12 inches under the surface; thence N.  $50\frac{1}{2}^{\circ}$  W. magnetic variation, 21° E. 4 chs. to the center of the County Road where a large medicine bottle is deposited 12 inches under the surface; thence N. 41 3/4° E. 5 chs. and 49 links where a bottle is deposited under the surface 12 inches; thence S. 503 E. 3 chs. and 74 links to the M.E. corner of Thomas Withey's former purchase; thence S. 39 % % 5 chs. and 50 links to the place of beginning, containing 2.12 acres, more

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
