CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That W. E. POINTER,

of Lexington, State of Oregon, has a right to the use of the waters of WILLOW CREEK, tributary of the Columbia River, in Morrow County, Oregon,

for the purpose of irrigation; (from April 1st to July 15th of each year)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 73; that the priority of the right hereby confirmed dates from 1901;

that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed 0.01 cubic feet per second.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

Lot five (5), Block 5, Town of Lexington, Oregon; being in Sec. 27, Tp. 1 S. R. 25 E., W. M., in Morrow County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

of Lexington, State of Oregon, 97839 has a right to the use of
the waters of WILLOW CREEK, tributary to the Columbia River, in Morrow County,
Oregon,

for the purpose of irrigation; (from April 1st to June 10th of each year)

and that said right has been confirmed by decree of the Circuit Court of the State of
Oregon for Morrow County, and the said decree entered of record at Salem,
in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at
page 73 ; that the priority of the right hereby confirmed dates from 1890;

that the amount of water to which such right is entitled and hereby confirmed for the
purpose aforesaid, is limited to an amount actually beneficially used for said pur-
pose , and shall not exceed 0.55 cubic feet per second.

A description of the lands irrigated under such right, and to which the water
hereby confirmed is appurtenant, or, if for other purposes, the place where such water
is put to beneficial use, is as follows:

Eighteen (18) acres in SW $\frac{1}{4}$ of NE $\frac{1}{4}$; five and one-half (5 $\frac{1}{2}$) acres in
NE $\frac{1}{4}$ of NW $\frac{1}{4}$; eight (8) acres in SE $\frac{1}{4}$ of NW $\frac{1}{4}$; one and one-half (1 $\frac{1}{2}$) acres
in NW $\frac{1}{4}$ of SE $\frac{1}{4}$; Sec. 28, Tp. 1 S. R. 25 E., W. M., in Morrow County, Oregon.
