CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That JAMES W. BEYMER, T. J. MERRILL, LAWRENCE SWEEK, J. C. OWEN

of Monument, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Cottonwood Creek, a tributary of John Day River

, for the purpose of the irrigation of 212.59 acres of land

under Enlargement Permit No. 15 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered

of record in the Record of Proceedings of said Board, at Salem, in Volume 1,

at page 257, on the 24th day of September, 1917; that the priority of the right hereby confirmed dates from August 5, 1909; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not

exceed 2.66 cubic feet per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 8 acres in the Northeast quarter of Northwest quarter; 6 acres in the Southeast quarter of Northwest quarter; 12 acres in the Northeast quarter of Southwest quarter and 11.10 acres in the Southeast quarter of Southwest quarter of Section Eighteen (18); 6 acres in the Northeast quarter of Northwest quarter; 2.12 acres in the Northeast quarter of Southwest quarter of Section Nineteen (19); 1.4 acres in the Northwest quarter of Northwest quarter; 33.14 acres in the Northwest quarter of Southwest quarter and 34.53 acres in the Southwest quarter of Southwest quarter of Section Six (6) 34 acres in Lot One; 35.15 acres in Lot Two of Section Seven (7), Township Nine (9) South, Range Twenty-eight (28); 10.35 acres in the Southeast quarter of Southeast quarter; 7.2 acres in the Northeast quarter of Southeast quarter of Section One (1) and 11.6 acres in the Northeast quarter of Northeast quarter of Section Twelve (12), Township Nine (9) South, Range Twenty-seven (27), All East of Willamette Meridian, in Grant County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
