CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That EASTERN OREGON LAND COMPANY, of Ontario State of Oregon has a right to the use of the waters of Willow Creek and South Fork of Willow Creek, tributary of Malheur River

for the purpose of the irrigation of 292.02 acres of land, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 3, at page 258 ; that the priority of the right hereby confirmed dates from the year 1867.

that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed a rate of flow of 7.30 sec. ft. from February 15th to May 1st and 3.65 sec. ft. from May 1st to September 1st of each year, or the equivalent in case of rotation; the total quantity diverted during each irrigation season not to exceed 876.06 acre feet.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 21.02 acres in the NW 1/4 NW 1/4; 39 acres in the NE 1/4 NW 1/4; 0.50 acre in SW 1/4 NW 1/4; 25 acres in SE 1/4 NW 1/4; 25 acres in NW 1/4 NE 1/4; 39 acres in SW 1/4 NE 1/4; 1.50 acres in NE 1/4 SW 1/4; 25.50 acres in NW SE 1/4; 2.50 acres in SW SE 1/4 Section 5; 37 acres in NE 1/4 NW 1/4; 28 acres in NW 1/4 NW 1/4; 20 acres in NE SE 1/4 NW 1/4; Section 9, Tp. 16 S., R. 43 E., 31 acres in SE 1/4 NE 1/4; 1 acre in NE 1/4 SE 1/4; 1 acre in SW 1/4 NE 1/4; Section 31, Tp. 15 S.R. 43 E.W.M., in Malheur County, Oregon.

This certificate is issued to amend that certain certificate recorded in Vol. 2, at page 1567 of State Record of Water Right Certificates, and in Vol. "E" at page 54 of Book of Water Right Certificates of Malheur County, in accordance with an order of the State Water Board made and entered on the 28th day of April, 1916, severing water rights from the lands described as "Tract No. 1" in said former certificate, and transferring said water rights to the lands above described in this certificate.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
