CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That RHODA A. SUMMER,

of Lexington, State of Oregon, 97837 has a right to the use of the waters of WILLOW CREEK, tributary to the Columbia River, in Morrow County, Oregon,

for the purpose of irrigation, (from March 1st to August 1st of each year)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 73; that the priority of the right hereby confirmed dates from 1872 for the irrigation of five (5) acres and from 1905 for the irrigation of thirty-five (35) acres;

that the amount of water to which such right is entitled and hereby confirmed for the purpose aforesaid, is limited to an amount actually beneficially used for said purpose, and shall not exceed 0.08 cubic feet per second as of date 1872 and 0.58 cubic feet per second as of date 1905.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:
