This Is to Certify, That ERNEST L. DURIN

of Route 1, Brooks , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Carnes Ditch

a tributary of Pudding River

for the purpose of

irrigation

under Permit No. 11688 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed daies from Hay 22, 1935

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 SE4 as projected on the James Webb D.L.C. No. 56, Section 11; and SW4 SW4 as projected on the James Webb D.L.C. No. 56, Section 12, Township 6 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent, for each acre irrigated,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.5 acres in SE3 SE3, Section 11; 14.0 acres in SW3 SW4, Section 12; As projected within the James Webb D.L.C. No. 56, T. 6 S., R. 2 W., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at an iron pipe in the South line of the James Webb Donation Land Claim, 35.12 chains Easterly from the South West corner of said Claim; in Township 6 South, Range 2 West of Willamette Meridian, in Marion County, Oregon; thence North 12' East, 11.913 chains to an iron pipe; thence East 20.30 chains to a point in the County Road; thence South 13' East in the County Road 11.913 chains; thence West on the South line of said Claim 20.35 chains to the place of beginning, and containing 24.23 acres of land more or less, and being a part of the James Webb Donation Land Claim in Township 6 South, Range 2 West of the Willamette Meridian, in Marion County, Oregon. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
