CERTIFICATE OF WATER RIGHT

This Is to Certify, That DONALD M. FISHER

of Route 1, Box 251, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Glenn Creek

a tributary of Willamette River

for the purpose of

irrigation

under Permit No. 13623 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 26, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.018 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWA NEA, as projected on Jesse Harriot D.L.C. No. 67, Section 16, Township 7 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres in SW1 NE4, as projected on Jesse Harriot D.L.C. No. 67; Section 16, T. 7 S., R. 3 W., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the NE corner of the Robt. Godfrey D.L.C. # 71 in T. 7 S. R. 3 W. W.M. in Polk County Oregon; Thence N 1° 15' W along the fence line 15.06 chains to an iron pipe; thence N 86° 30' E along fence line 4.32 chains to ME Corner of Lot Three(3) in Sec 16 of said township and range, which NE corner is situated in the center line of the Wallace Road; thence N 25° 30' W along the center line of said road 4.80 chains more or less to an old division fence; Thence W. 19.23 chains; thence S. 20.0 chains; thence E. 17.63 chains more or less to place of beginning, in Sec 16, T. 7 S. R. 3 W. W.M., Polk County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
