CERTIFICATE OF WATER RIGHT

This Is to Certify, That IRVIN SHATTO

of Route 2, Box 98, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of umnamed stream and Butte Creek

a tributary of Pudding River for the purpose of

irrigation

under Permit No. 15278 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 19, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.325 cubic feet per second to be used from unnamed stream when sufficient water is available and any deficiency is to be made up from Butte Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWT NWT, as projected on Thomas Chase D.L.C. #46, Section 25 and SWT SWT, as projected on Thomas Chase D.L.C. #46, Section 24, Township 5 South, Range 1 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.8 acres in SW_3^1 SW_3^2 , as projected on Thomas Chase D.L.C. #46, Sec. 24; 10.2 acres in NW_3^1 , as projected on Thomas Chase D.L.C. #46, Sec. 25; T. 5 S., R. 1 W., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the southeast corner of the Thomas Chase D.L.C. in T.5.S.R.1.W. of the Willamette Meridian in Clackamas County, Oregon; thence N. 39° W. in the center of Butte Creek 5.50 chains thence N. 66° W. still down the center of said creek 6.33 chains; thence N. 3°4' E. 52.96 chains to a plow shear; thence S. 89°43' E. 6.40 chains; thence S. 1°15' E. 25 links to an angle in said claim; thence S. along the E. line of said claim 59.46 chains to the point of beginning, containing 43.80 acres of land in the Thomas Chase D.L.D. in T. 5.S.R.l.W. of the W.M., Clackamas County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
