of Route 1 Box 193 Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

an unnamed slough attributary of Willamette River

for the purpose of

imdes remain No. 17093 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 4, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.485 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (NW4 SW4), Section 15, Township 7 South, Range 3 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.8 acres in Lot 7 (SW\(\frac{1}{4}\) NW\(\frac{1}{4}\))
1.6 acres in SW\(\frac{1}{4}\) NW\(\frac{1}{4}\), as projected on Jesse Harriot D.L.C. #67
5.8 acres in Lot 11 (NE\(\frac{1}{4}\) SW\(\frac{1}{4}\))
9.0 acres in Lot 6 (NW\(\frac{1}{4}\) SW\(\frac{1}{4}\))
0.6 acre in Lot 5 (SE\(\frac{1}{4}\) SW\(\frac{1}{4}\))

1.0 acre in SE1 NW1, as projected

SAVE AND EXCEPT therefrom those certain premises conveyed to Wilson C. Dibble and Nellie M. Dibble, his wife, as shown in Volume 58, on page 317, Deed Records for Polk County, Oregon; and also save and except that certain tract of land conveyed by Martha Moeler, unmarried, to Joseph Thiel, May 23, 1914, as shown in Volume 60, on page 41, Deed Records for Polk County Oregon, on May 25, 1914.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
