CERTIFICATE OF WATER RIGHT

This Is to Certify, That SAM F. & ANNIE L. MEDFORD

of B.B. Route, Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork Willamette River a tributary of Willamette River for the purpose of

irrigation
under Permit No. 17368 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from November 13, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.195 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW1 SW1, Section 32, Township 22 South, Range 3 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 15.6 acres in NW1 SW1, Section 32, T. 22 S., R. 3 W., W.M. Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

appropriator as follows:
Beginning at a point on the easterly boundary of the W. A. Woodard Lumber Company's road right of way 274 feet east of the quarter corner between Sections 31 and 32, thence east following the quarter line of Section 32 1046 feet more or less, to the quarter-quarter corner, thence south 500 feet or to the middle of the channel of the Coast Fork River, thence southwesterly following the channel of the Wat of the SW4 of Section 32, thence west 100 feet more or less, to a point on the south boundary of the WW4 of the SW4 of Section 32, thence west 100 feet more or less, to a point on the easterly boundary of the W. A. Woodard Lumber Company's road right of way at Sta. 65 34.5, thence following said easterly boundary of said right of way 30 feet out from a two degree curve to the right on the center line 139.5 feet to Sta. 66 74 E.C., thence continuing on said easterly boundary of said right of way north 25 20' west 1239 feet to Sta. 79 13 B.C., thence following said easterly boundary 30 feet out from a five degree curve to the right on the center line 70 feet to Sta. 79 77 or to the place of beginning, embracing 20 acres more or less and is intended to convey all of that portion of the NW7 SW4 Section 32, Twp. 22-S-R-3-W, W.M., between the W. A. Woodard Lumber Company's easterly road boundary and the Bomis property.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
