CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLIAM E. WILLIAMS

of S. Myrtle Route, Myrtle Creek, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of South Myrtle Creek for the purpose of irrigation and domestic use for one family under Permit No. 17951 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 9, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.07 cubic feet per second, being 0.06 c.f.s. for irrigation and 0.01 c.f.s. for domestic.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 29, Township 29 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$
Domestic and
3.4 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$
Section 29, Township 29 South, Range 4 West, W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

N.E. one quarter and N. half of the N.W. quarter of section 29 Twnship 29, south range 4 west of Willamette Meridian containing 240 acres.

Excepting therefrom that part sold to A V Buffington as described in deed recorded in volume 89 Page 572 of the deed records of Douglas County. Also excepting therefrom that part sold to W.C. Brownson by deed recorded Volume 92 page 503 of deed records of Doug. Cty. Land conveyed containing in all an aggregate of 191.75 acres more or less excepting therefrom the county road passing thru said property.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
