CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. FOREST SIMMONS

of Route 7, Box 345-E, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Little Pudding River a tributary of Pudding River for the purpose of irrigation

under Permit No. 18593 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 7, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.058 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NE: NH1), Section 34, Township 6 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.6 acres in Lot 2 (NEA NWA), Section 34

Township 6 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning on the North Boundary of the Donation Land Claim of Thomas C. Howell and wife same being Claim No. 47 in Township 6 South of Range 2 West of the Willamette Meridian in Marion County, Oregon, at a point which is 5.19 chains West of the most Westerly Southwest corner of the Donation Land Claim of Wesley Howell and wife and from thence running North, parallel with the center line of Section 34 in said Township and Range, 5.84 chains to the center line of the County Road; thence South 83° O4' West, along the center line of said Road 7.30 chains; thence South 74° 14' West along the center lire of 'aid Road, 5.04 chains to the middle of Little Pudding River; thence Southwesterly following the meanderins of said river up stream to the North boundary of said Donation Land Claim No. 47; thence East 14.62 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
